When returning product that is not defective, damaged, or a EuroAmerican IP or manufacturer shipping error, the following terms and conditions apply, (a) items must be received in unopened cases with original packaging intact, (b) items with "piggyback labels" will not be accepted (these fall into the made to order category), (c) items not in salable condition due to improper storage, spoilage, or damaged packaging are not returnable. In the event the products arrive in damaged condition,

a credit will be issued upon return and receipt of merchandise at our location. Returns that are not for defect damage or error will be subject to the following restocking amounts, based on the date of the original invoice:

Our products have a 100% Warranty Guarantee and are fully refundable within the first 30 days from date of purchase, excluding shipping. Your original method of payment will be credited within 72 hours of receipt of return, less shipping.
